Sec. 34-19(9)(b) Parking lot needs to be re-sealed and re-striped.

A Notice of Violation was issued on August 25, 2023. During the December 6, 2023 Code Enforcement Board Hearing, the Board determined the Respondent is in violation of Sec. 34-19(9)(b), and the Respondent must come into compliance by May 22, 2024, or a fine of \$50.00 per day may be imposed until compliance is achieved. The Board also ordered the Respondent to provide a monthly status update to the Code Enforcement Officer. During the May 22, 2024 Code Enforcement Board Hearing, the

Board determined the Respondent remains in violation, and extended the date of compliance to July 23, 2024. The Board ordered the Respondent to come to the June 26, 2024 Code Enforcement Board Hearing to provide a status update.

Sec. 34-19(9)(b) Painted driveway is faded with spots and needs repainting.

A Notice of Violation was issued on February 7, 2024. During the April 24, 2024 Code Enforcement Board Hearing, the Board determined the Respondents are in violation of Sec. 34-19(9)(b), and the Respondents must come into compliance by the next Code Enforcement Board Hearing on May 22, 2024, or a fine of \$75.00 per day may be imposed until compliance is achieved. During the May 22, 2024 Code Enforcement Board Hearing, the Board determined the Respondents remain in violation, and extended the date of compliance to July 23, 2024. The Board ordered the Respondents to come to the June 26, 2024 Code Enforcement Board Hearing to provide a status update.

During the January 24, 2024 Code Enforcement Board Hearing, the Board determined the Respondent is in violation, and the Respondent must come into compliance by February 28, 2024, or a fine of \$250.00 per day may be imposed until compliance is achieved. During the February 28, 2024 Code Enforcement Board Hearing, the Board determined the Respondent remains in violation, and imposed a fine of \$250.00 per day, plus administrative costs, if any, commencing on February 28, 2024 until compliance is achieved. The total fine amount due is \$30,000, plus administrative costs to record the lien.

Sec. 125-767 Boats/trailers cannot be stored in the driveway

A Notice of Violation was issued on January 3, 2024. During the January 24, 2024 Code Enforcement Board Hearing, the Board determined the Respondent is in violation of Sec. 125-767, and the Respondent must come into compliance by February 28, 2024, or a fine of \$50.00 per day may be imposed until compliance is achieved. During the February 28, 2024 Code Enforcement Board Hearing, the Board determined the Respondent remains in violation, and imposed a fine of \$50.00 per day, plus administrative costs, if any, commencing on February 28, 2024 until compliance is achieved. The Respondent came into compliance on March 14, 2024. The total fine amount due is \$750.00, plus administrative costs to record the lien.
